1. Definitions

“Board” – The Board of Directors of Volleyball Canada or a Provincial/Territorial Association, as applicable

“Contractors” – Persons contracted with Volleyball Canada and/or a Provincial/Territorial Association, such as an integrated support team member.

“Criminal Record Check (CRC)” – A search of the RCMP Canadian Police Information Centre (CPIC) system for adult convictions

“Enhanced Police Information Check (E-PIC)” – a criminal record check plus a search of local police information, available from Sterling Backcheck

“Individuals” - refers to all categories of members and/or registrants defined in the Bylaws of Volleyball Canada and in the Bylaws of a Provincial/Territorial Association as well as all people employed by, contracted by, or engaged in activities with, Volleyball Canada or a Provincial/Territorial Association including, but not limited to, employees, contractors, athletes, volleyball clubs, coaches, mission staff, referees, volunteers, managers, administrators, committee members, parents or guardians, spectators, and directors and officers

“Local Police Information (LPI)” – additional conviction and selected non-conviction information in national and local police data sources which may be relevant to the position sought

“Minors” – Persons under the age of majority.

“Organization” – Volleyball Canada and/or Provincial and Territorial Associations

“Provincial/Territorial Associations” – the provincial/territorial member governing bodies for volleyball in each province/territory

“Vulnerable Individuals” – A person under the age of 18 years old and/or a person who, because of age, disability or other circumstance, is in a position of dependence on others or is otherwise at a greater risk than the general population of being harmed by people in positions of trust or authority

“Vulnerable Sector Check (VSC)” – a detailed check that includes a search of the RCMP Information Centre (CPIC) system, local police information, and the Pardoned Sex Offender database.

2. Purpose

2.1 The purpose of this policy is to provide screening procedures for Volleyball Canada and the Provincial/Territorial Associations.

3. Application

3.1 This policy applies to all Individuals whose position with Volleyball Canada or a Provincial/Territorial Association is one of trust or authority which may relate to, at a minimum, finances, supervision, or Vulnerable Individuals.

3.2 Volleyball Canada and Provincial /Territorial Associations believe that screening Individuals cannot be a stand-alone practice but is a vital part of supporting a safe sporting environment for participants.

4. Provisions

4.1 Not all individuals associated with Volleyball Canada or a Provincial/Territorial Association will be required to obtain a criminal record check or submit screening documents. Volleyball Canada, and/or a Provincial/Territorial Association will determine which individuals will be subject to screening using the following guidelines. Each organization may vary the guidelines at its discretion:

a) Low Risk - Individuals involved in low risk assignments who are not in a supervisory role, not directing others, not involved with finances, and/or do not have unsupervised access to Vulnerable Individuals. Examples:

Parents, youth, or volunteers who are helping on a non-regular or informal basis

Non-coach employees or managers who do not travel with athletes

b) High Risk – Individuals involved in high- risk assignments who occupy positions of trust and/or authority, have a supervisory role, direct others, are involved with finances, and who have frequent or unsupervised access to Vulnerable Individuals. Examples:

Athlete support personnel

Full-time coaches and/or assistant coaches

Coaches and/or contractors who travel with athletes

Coaches and/or representatives who could be alone with athletes

Referees

Staff and/or directors and supervisors

4.2 Volleyball Canada and/or the Provincial/Territorial Associations may decide that an Individual's prior E-PIC is acceptable if it has been completed within the last three years. In such cases, an Individual must share a copy of the E-PIC with the Screening Committee. If an Individual is not able to produce the E-PIC, the Screening Committee will request that the Individual undergo a new E-PIC.

4.3 Volleyball BC recognizes that some Individuals may be unable to secure an E-PIC or similar screening from Canadian authorities (eg. if they are New to Canada). In these situations, Volleyball BC may accept screening documentation from the country of residence in which the Individual has resided over the past 3 years.

5. Screening Committee

5.1 A Screening Committee (composed of one to three persons appointed by the administrative head of the Organization) is responsible for the implementation of this policy. Volleyball Canada and Provincial/Territorial Associations will ensure that the person(s) appointed to their respective Screening Committees possess the requisite skills, knowledge and abilities to implement this policy.

5.2 Screening Committee members may be staff members of Volleyball Canada or a Provincial/Territorial Association.

5.3 The Screening Committee will carry out its duties, in accordance with the terms of this policy. Should the Screening Committee be composed of staff members, the staff members may discuss screening issues with the Chief Executive Officer / Executive Director and/or a designated individual.

5.4 The Screening Committee will review all documents submitted and, based on the review, make decisions regarding the appropriateness of Individuals filling positions within Volleyball Canada or a Provincial/Territorial Association, as applicable. In carrying out its duties, the Screening Committee may consult with independent experts including lawyers, police, risk management consultants, volunteer screening specialists, or any other person.

- 5.5 Nothing in this policy restricts or limits the Screening Committee from requesting that the individual attends an interview with the Screening Committee if the Screening Committee considers that an interview is appropriate and necessary to screen the individual's application.
- 5.6 Nothing in this policy restricts or limits the Screening Committee from requesting the individual's authorization to contact any professional, sporting or other organization in order to assess the suitability for the position that they are seeking.
- 5.7 Nothing in this policy restricts or limits the Screening Committee from requesting further information from the Individual on more than one occasion, subject to the individual's right to insist that the Screening Committee make a decision on the basis of the information before it.
- 5.8 An Individual having been previously penalized for a prior offence shall not prevent the Screening Committee from considering that offence as part of the individual's screening application.
- 5.9 An Individual whose screening application has been denied or revoked may not re-apply to participate in the organization's programs or activities for a minimum of 1 year from the date the rejected application was made, or longer depending if a relevant offense is found as stated in section 9.10.

6. Screening Requirements

- 6.1 When an Individual is first engaged by Volleyball Canada or by a Provincial/Territorial Association, as applicable, they must submit the following requirements (which may be varied at the sole discretion of the Screening Committee):
- a) Low Risk Individuals:
 - i. Complete an Application Form (see Appendix A for a sample)
 - ii. Complete a Screening Disclosure Form (Appendix B)
 - iii. Participate in training, orientation, and monitoring as determined by the Organization
 - b) All Individuals with the exception of those identified to be in the category above:
 - i. Complete an Application Form
 - ii. Complete a Screening Disclosure Form
 - iii. Complete and provide an E-PIC and/or a VSC, if requested by Volleyball Canada and/or a Provincial/Territorial Association
 - iv. Participate in training, orientation, and monitoring as determined by the Organization
 - v. Provide a driver's abstract, if requested
 - c) If an individual subsequently receives a charge, conviction for, or is found guilty of, an offense they will report this circumstance immediately to Volleyball Canada or to the Provincial/Territorial Association, as applicable. Individuals must also inform the Organization of any changes in their circumstance that would alter their original responses in their screening disclosure form.
 - d) If Volleyball Canada or a Provincial/Territorial Association learns that an Individual has provided false, inaccurate, or misleading information, the Individual will immediately be removed from their position and may be subject to further discipline in accordance with the Discipline and Complaints Policy.
- 6.2 If an Individual requires assistance or has questions about the screening requirements, they may contact Member Services at members@volleyballbc.org or at 604 291 2007.

7. Minors

- 7.1 Volleyball Canada and Provincial/Territorial Associations will not require Minors to obtain a VSC or E-PIC.
- 7.2 Notwithstanding the above, Volleyball Canada or a Provincial/Territorial Association may ask a Minor to obtain a VSC or E-PIC if the Organization suspects the Minor has an adult conviction and therefore has a criminal record. In these circumstances, the Organization will be clear in its request that it is not asking for the Minor's youth record. Volleyball Canada and the Provincial/Territorial Associations understand that they may not request to see a Minor's record.

8. Renewal

- 8.1 Unless the Screening Committee determines, on a case-by-case basis, to modify the submission requirements, Individuals who are required to submit an E-PIC, Screening Disclosure Form, VSC, or Screening Renewal Form, are required to submit the documents as follows:
- a) An E-PIC every three years
 - b) A Screening Disclosure Form every year
 - c) A Vulnerable Sector Check once
- 8.2 Volleyball Canada and/or a Provincial/Territorial Association may request that an Individual provide any of the above documents at any time. Such a request will be in writing and reasons will be provided for the request.

9. Orientation, Training, and Monitoring

- 9.1 Volleyball Canada or a Provincial/Territorial Association, as applicable. In their sole discretion, will determine the type and amount of orientation, training, and monitoring based on the Individual's level of risk.
- 9.2 Orientation may include, but is not limited to introductory presentations, facility tours, equipment demonstrations, parent/athlete meetings, meetings with colleagues and supervisors, orientation manuals, orientation sessions, and increased supervision during initial tasks or initial period of engagement.
- 9.3 Training may include, but is not limited to certification courses, online learning, mentoring, workshop sessions, webinars, on-site demonstrations, and peer feedback.
- 9.4 Volleyball Canada, and the Provincial/Territorial Associations as applicable, may, at the conclusion of orientation and training, require the Individual to acknowledge in writing that they have received and completed the orientation and training.
- 9.5 Monitoring may include but is not limited to: written or oral reports, observations, tracking, electronic surveillance (e.g., facility security cameras), and site visits.
- 9.6 Volleyball BC values diversity in the workplace and will provide reasonable accommodations for orientation, training, and monitoring activities. If an Individual has requirements or questions, they should contact their Manager or the Head of Operations.

10. Screening Outcomes

- 9.7 An Individual who refuses or fails to provide the necessary screening documents will be ineligible to volunteer or apply for the position sought. The Individual will be informed that their application and/or position will not proceed until such time as the screening documents are submitted.
- 9.8 Volleyball Canada and Provincial/Territorial Associations understand that there may be delays in receiving the results of an E-PIC or a VSC. At its discretion, the Screening Committee may permit the Individual to participate in the role during the delay. This permission may be withdrawn at any time and for any reason.
- 9.9 Following the review of the screening documents, the Screening Committee will decide:
- a) The Individual has passed screening and may participate in the desired position;
 - b) The Individual has passed screening and may participate in the desired position with conditions;
 - c) The Individual has not passed screening and may not participate in the desired position; or
 - d) More information is required from the Individual
- 9.10 In making its decision, the Screening Committee will, if any convictions are disclosed, consider the type of offense, date of offense, and relevance of the offense to the position sought.

9.11 If the screening documentation reveals any of the following convictions, the Screening Committee will determine the Individual has not passed screening (unless an exception is made by the Screening Committee, in its sole discretion, and its detailed reasons are provided to the Chief Executive Officer / Executive Director):

- a) If imposed in the last three years:
 - i. Any individual's conviction for an offence involving the use of a motor vehicle, including but not limited to impaired driving
- b) If imposed in the last ten years:
 - i. Any individual's conviction involving theft or fraud
 - ii. Any Individual's conviction for an offence of possession of illegal drugs
- c) If imposed at any time:
 - i. An individual's conviction for any of the following Criminal Code offenses:
 - a. Physical or psychological violence
 - b. crime of violence including but not limited to, all forms of assault
 - c. trafficking of illegal drugs and/or performance enhancing drugs
 - d. possession, distribution, or sale of any child-related pornography
 - e. sexual misconduct
 - f. any criminal offence involving a minor.

10. Conditions and Monitoring

10.1 The Screening Committee may determine that incidents revealed on an Individual's screening documents may allow the Individual to pass the screening process and participate in a desired position with conditions imposed. The Screening Committee may apply and remove conditions at its discretion and will determine the means by which adherence to conditions may be monitored.

11. Records

11.1 All records will be maintained in a confidential manner as applicable and will not be disclosed to others who are not members of the Screening Committee except as required by law, for use in legal, quasi-legal, or disciplinary proceedings.

11.2 The records kept as part of the screening process include but are not limited to:

- a) An Individual's Vulnerable Sector Check
- b) An Individual's E-PIC (for a period of three years)
- c) An Individual's Screening Disclosure Form (for a period of one year)
- d) Records of any conditions attached to an Individual's registration by the Screening Committee
- e) Records of any discipline applied to any Individual by Volleyball Canada, a Provincial/Territorial Association, or another sport organization

12. Communication

12.1 Volleyball Canada and the Provincial/Territorial Associations will identify those persons within their respective organizations who will be responsible for implementing this policy.

13. Policy Review and Monitoring

13.1 Volleyball BC will review this Policy every 2 years.

13.2 The HR and Governance Committee and Board of Directors will receive information about compliance and any reported impacts or unintended consequences of the Policy.
